JOINT COMMUNICATION BULLETIN

OUTCOMES FROM THE JOINT MEETING HELD ON 13 MARCH

♦ RPA Staff Severance Scheme for Local Government

Members agreed to issue the Scheme as a Joint Forum Circular recommending adoption by councils. The Trade Union Side again recorded its position in respect of the need for a centrally funded staff severance scheme.

Scheme of Transfer for Local Government Staff

Members agreed the Scheme subject to clarification in relation to relevant provision of the Local Government (Reorganisation) Bill which will govern implementation of the Scheme.

- ◆ Local Consultation and Negotiation Forums at Transition Committee Level
 Circular LGRJF/04 issued in October 2012 requires councils to engage with their local NIJC
 recognised Trade Unions. The Joint Forum sees Local Forums as a valuable resource for
 implementing reform. The Joint Forum has asked that Local Forums provide details of
 their agreed Terms of Reference and Operating Arrangements and forward Work Plans.
- ♦ Vacancy Control System—Monitoring 1 November 2012 to 31 January 2013 and the Implementation of Phase 2

Local Forums have been asked to provide the Joint Forum with details on the application of Vacancy Controls in the period from 1 November 2012 to 31 January 2013. Views are also sought on the range of posts to be included in Phase 2 of Vacancy Controls and the most appropriate timing for this to be introduced. Phase 2 includes all the remaining potentially "at risk" posts. The information is to be returned to the Joint Forum by Tuesday 30 April 2013.

 Discussion Paper on a Future Industrial Relations Framework for Local Government in Northern Ireland

Members endorsed the planned consultation on a draft Industrial Relation Model prepared by the Employee Relations Working Group within the People and Organisation Strategic Framework. The consultation document will be issued to stakeholders in April.

FUTURE WORK

The Joint Forum has agreed to continue to progress work in respect of:

- The development of a revised Code of Conduct for Local Government Employees
- The potential for the harmonization of Terms and Conditions post implementation of reform
- Location, Relocation and Expenses
- A new approach to recruiting and developing local government staff.
- Progress across councils on the implementation of Single Status Arrangements.
